(temporary instruction permit) from the Sec. of State's office, which will require passing a 50 question written exam. WCMDE offers 3 different Adult instruction options: (please choose one) □ A. Full course instruction of Segment I at our normal cost of \$350 - This is for the over 18 yr old adult who wishes to receive the same comprehensive 24 hrs of classroom and 6 hrs behind-the-wheel instruction that is offered to teenage students enrolled in the State of Michigan's Graduated Drivers License Program. □ **B.** One-on-one instruction within the vehicle - to be done by the hour at a flat rate of \$60/hr. It is understood that the amount of hours of behind the wheel instruction needed for any given adult student is by nature an unknown factor. The instructor will treat each student individually and assess progress at the end of each session to determine the need for additional hours behind the wheel. Agreement by both student and instructor will be necessary. □ C. Road Test Prep Course - This short course is aimed at adults concerned about passing the **Road Skills Test.** For a \$60 fee, the instructor will spend 2 hrs, one-on-one,

going over knowledge and skill requirements, assessing skills or habits that could prohibit passing the road test. Instruction is based on the Road Skills Test booklet (@SOS), and

one or more of those hours will be spent operating the vehicle.

Payment shall be made in full by cash or money order at the beginning of the selected instruction session, A, B, or C.

While all of the above options are aimed at giving each student skill and knowledge, it is not possible for WCMDE to guarantee the actual passing of the Road Skills Test necessary to acquire a Driver's license. The individual student faces those challenges on his/her own merit.

West Central Michigan Driver Education will conduct the behind-the-wheel instruction in a dual controlled automobile, fully insured for training purposes.

It is understood that the adult student who is contracting with West Central Michigan Driver Education is contracting for an amount of time for classroom and/or behind-the-wheel-instruction, and **not for any sort of testing service.** Official road testing is always done by State appointed "Third Party Testers".

There shall be no charge to students for any classroom materials used, if classroom instruction is requested. If the student wishes to own the textbook, the purchase fee is \$20.

The school instructor may cancel this contract at any time, for any reason. Likewise for the student.

In the event that the instructor must cancel instruction or classes on any given day, for any reason (such as sickness or mechanical problems), the instruction will be rescheduled on a day that is mutually agreeable to both the student and the instructor.

WCMDE welcomes inviting an additional adult passenger to ride in the back seat, however, that passenger must in no way interfere with the instruction being given. Minor passengers are not allowed.

Notice: This school is required to be licensed by the Michigan Department of State, Program Operations Division.
